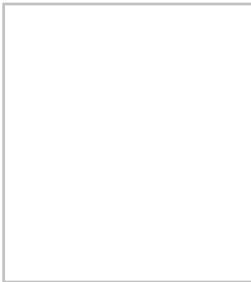

Month Long Fire Fight - The Rim Fire



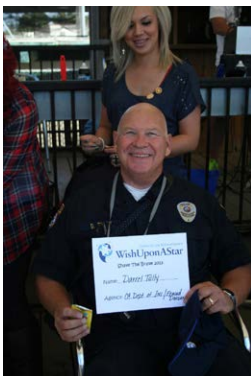
