

SUMMARY ANNUAL REPORT FOR
CALIFORNIA STATEWIDE LAW ENFORCEMENT ASSOCIATION
LEGAL DEFENSE FUND

This is a summary of the annual report of California Statewide Law Enforcement Association Legal Defense Fund, EIN 68-0219855, for the year ended December 31, 2016. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the California Statewide Law Enforcement Association Legal Defense Fund has committed itself to pay certain legal claims incurred under the terms of the plan.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,711,881 as of December 31, 2016, compared to \$1,624,190 as of January 1, 2016. During the plan year, the plan experienced an increase in its net assets of \$87,691. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$238,703, including participant contributions of \$129,616 and earnings from investments of \$109,087.

Plan expenses were \$151,012. These expenses included \$63,186 in administrative expenses, and \$87,826 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, 2029 H Street, Sacramento, California 95814, and at the U.S. Department of Labor in Washington, DC or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
