## A Message From CSLEA President Alan Barcelona



I want to thank you, in advance, for your patience as we approach two hurdles in our jobs of supporting you in your careers and your livelihood.

The first is negotiating a contract for our 7,000 law enforcement, public safety and consumer protection professionals. The Great Recession has taken its toll on our paychecks, savings and spending power. We have received your message loud and clear, "enough is enough." Your elected board members experience what you experience and it is, at times, exasperating.

I hear the growing impatience as it is announced another bargaining unit has reached a contract agreement with the state. I hear the requests for more information as to what is on the bargaining table. I hope you can respect the need to keep this information confidential during the negotiations period. We are still in the bargaining process but hope to finalize a new tentative agreement shortly.

The second hurdle involves POC's attempt with AFSCME to decertify CSLEA. This requires a lot of CSLEA time and effort, and patience on your part, as we work to keep you informed of ...read more.
