

The Negotiation Process

The CSLEA negotiation team consists of CSLEA's three vice presidents, Chief Counsel Kasey Clark and myself. CSLEA affiliate presidents submit items their members would like to see passed across the table. CSLEA members should talk to their affiliate presidents about issues they feel need to be negotiated and why. During negotiations, affiliate presidents will be called to the table, or will bring members to present at the table, or both. It is the person doing the job who can best explain to negotiators why things need to be fixed or why certain compensation needs to be implemented. It is important for us to include members in this process. Negotiations begin in Spring 2016. Don't wait to let your voice be heard.




