### PRESIDENT'S MESSAGE



Sadly, we are grieving the loss of two California peace officers, CHP Officer Andrew Camilleri who died in the line of duty on Christmas Eve when a suspected drunk & drugged driver hit his patrol car, and San Bernardino County Sheriff's Deputy Larry Falce who died New Year's Eve from his injuries after he was



violently attacked during an off-duty vehicle accident. These officers served and protected their communities and we pray for their families, friends and departments as we know there is a vast and forever void in their lives.





The sadness surrounding their deaths reminds me to bring to the forefront the California Peace Officers' Memorial, which is located across from the Capitol in Sacramento.



and the State of California.


