CONTRACT UPDATE: New Unit 7 Contract Signed by Governor Newsom

Hello CSLEA members,

We received the good news late yesterday afternoon that Governor Gavin Newsom signed Assembly Bill 118 which included the Memorandum of Understanding (MOU) between the California Statewide Law Enforcement Association (CSLEA) Bargaining Unit 7 and the State.

The governor's action finalizes the 2019-2023 contract and was necessary before any pay

raises can be issued. CSLEA has been informed that the retro checks or check for the general salary increase and special salary adjustments will likely be issued in late December and will be separate from regular payroll. Taxes for the retro pay will be aggregate for the respective pay periods.

I want to thank you for your patience during the lengthy process of negotiations, ratification and the implementation of our contract. CSLEA's work for members does not stop here. We are always doing our best to enhance the pay, benefit and working condition issues that impact our members. Please continue to communicate with us, as we work on your behalf. FAMILY PLANNING?

Pregnancy Disability Income Benefit through **Allstate Benefits**

CSLEA members have the opportunity to receive disability income up to \$1800 a month for pregnancy leave through Allstate Benefits. The accident policy provides on-or-off the job, 24 hour, accidental disability income and has a sickness disability income rider which includes pregnancy income.

The illness rider coverage has to be purchased as part of the accident policy. In addition to income for time off due to illness or surgery, the rider will cover maternity as any other illness, provided the policy has been in effect 10 months at time of birth. This means that coverage is not available if you are currently pregnant.
