PRESIDENT'S UPDATE

Hello CSLEA Members,

We are approaching the February 28<sup>th</sup> deadline for accepting contract proposals from CSLEA members. It is evident that our members who have submitted items for collective bargaining consideration have put much work into their proposals. I am encouraged by the participation and thank our members who are choosing to become involved in our work to improve your daily lives. While formal negotiations are not yet underway, having your collective bargaining proposals now gives CSLEA leadership and the negotiations team ample time to research them and draft items to be brought to the negotiations table with the state.



While this is an important time for all of us as we push to improve your livelihood, it is not just at contract negotiation time that we diligently work on your behalf. CSLEA directors and staff work year-round, every year to bring your issues and items to the attention of your departments, legislators and the administration. I very much encourage you to read "Why Union Membership Matters" in today's newsletter. Why? Because it answers the question, "what has my union done for me?" and highlights the work that CSLEA has done and accomplished January 2022 through January 2023. Some of the work by our legal team begins with a simple phone call or email to CSLEA from one of our members inquiring about treatment or policy. Remember, we are here to serve you and are very responsive to your inquiries.

Other items I would like to bring to your attention:

- The CSLEA Foundation Scholarship application for 2023 will be emailed later this month, so please look for that in your inbox and let your fellow CSLEA members with collegeaged students know! Thanks to donations, CSLEA will be awarding eight \$1,000 scholarships!
- CLEA's 2023 Children's Scholarship Program is now accepting applications. This is for CLEA long-term disability plan participants. Please don't confuse CLEA's scholarship program with CSLEA's!
- PORAC's 2023 scholarship applications are also available with a submission deadline of March 3<sup>rd</sup>.
- CSLEA is co-sponsoring <u>SB 391</u>, legislation that would enable CDFW wardens and State
  Parks rangers to more easily access workers' compensation benefits for skin cancer
  diagnoses and treatment. The legislature unanimously passed similar legislation last

year, however it was vetoed by the Governor. We will continue to pursue this important effort.

- CSLEA is also working to reintroduce a bill CSLEA sponsored last year relating to a
  PTSD presumption, adding additional first responders in California to the list of those
  who are already covered by the workers' compensation system in this regard. This would
  greatly assist CSLEA members including dispatchers. The legislature passed this bill
  last year, but the Governor declined to sign it into law.
- And welcome to 92 of our newest members who joined our union last month, recognizing
  that together we are a stronger voice and knowing that they have the protection, safety
  net, and support of a top-notch team dedicated to working for them.

Please feel comfortable in calling us or emailing us with any of your questions, concerns or feedback – and again, thank you for your valued membership to CSLEA, together, we truly do make a difference.



### An overview of emergency services work being provided by FMESA members by FMESA President and CSLEA Director BJ Jones

SACRAMENTO – At an unprecedented time when the state of California is experiencing bomb cyclones, atmospheric rivers, flooding, strong wind, damaged homes and roadways, power outages and even loss of life, California Statewide Law Enforcement Association(CSLEA) and Fire Marshal Emergency Services Association (FMESA) members at Cal OES are deployed throughout the state and at the Cal OES State Operations Center in response to various flood issues. They are law enforcement officers, fire-rescue personnel and emergency services coordinators (ESCs). Many of these public safety professionals are deployed geographically to County Emergency Operation Centers and are coordinating resource requests from the various operational areas. Cal OES prepositioned flood response resources and equipment throughout the state of California including California National Guard assets.

Special Service Award (Silver)

On December 18, 2020, while traveling home from a 12-hour duty shift at the Emergency Communications Center in San Bernardino, CA, off-duty Department of Forestry and Fire Protection Communications Operator Barbara Loescher found herself at the scene of a major traffic collision in Crestline, CA. There were two vehicles, one of which was on fire, the other which contained an unconscious passenger. Ms. Loescher began administering cardiopulmonary resuscitation (CPR), after determining the unconscious passenger was not breathing, until on-duty first responders arrived at scene. The driver of the other vehicle attempted to flee the



scene. Ms. Loescher leveraged her experience as a former California Highway Patrol Communications Operator to successfully detain the driver until police officers arrived. With no regard for her own safety, Ms. Loescher went above and beyond the call of duty. The State of California takes great pride in presenting the Silver Medal of Valor to Department of Forestry and Fire Protection Communications Operator Barbara Loescher.
